## TOWNSHIP SPRING CLEANUP EVENTS

### Branch Pickup

**Monday - Friday, April 11-15**

The road crew will come by only ONCE during the week so have your branches out on Monday. They will not be collected unless they are properly prepared. If you have questions call Roadmaster, Dave Allen, at 610-388-9180.

This program is for residents to get rid of fallen limbs or small trees. IT IS NOT TO BE USED AS A COMMERCIAL TREE SERVICE OR FOR LOT CLEARING.

The Township mulch pile is available for residents' use. Contact Dave Allen to coordinate pickup or with questions.

#### *Preparation of brush and limbs:*

- Brush and limbs must be from your Pennsbury Township property.
- Roots stumps and limbs with wire and/or nails will NOT be picked up.
- All brush and limbs must be in the right of way.
- Dry, dead brush and tree limbs must be tied in bundles 3' long or less. Each bundle should be not greater than 12" in diameter.
- Fresh-cut (green) limbs, 2" in diameter and larger, should be left full length, placed along roadside with large ends closest to the road, not in a random pile.
- Only 8 bundles of brush and/or tree limbs and 10 fresh cut branches are allowed per property.

This is FREE for Pennsbury Township residents and will be held in the Township Building parking lot. No commercial businesses.

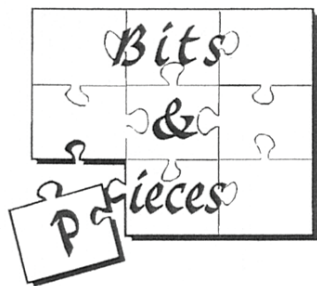

## ❖ SPRING TIPS FOR REDUCING STORMWATER RUNOFF

- Plant a large stature tree. They are great for stormwater control. At maturity they intercept over 1,000 gallons of rainwater each year. Their foliage and bark intercept rainfall, and their canopies also reduce the force of rain hitting the soil, reducing erosion.

- When you fertilize the lawn, you're not just fertilizing the lawn. Excess nitrogen and phosphorus from lawn fertilization is frequently a pollutant to streams by fostering the

# Township Restrictions on Open Burning

Pennsbury Township Zoning Ordinance 162-1911, sets strict limitations on open burning.

- Open burning of anything other than leaves and small branches is strictly prohibited at all times. There shall be no emission of smoke, ash, dust, fumes, vapors, gases, or other matter toxic or noxious to air which violates the Pennsylvania Air Pollution Control Laws.

- Open burning of leaves and small branches is prohibited during the following intervals:

On weekends and Holidays at any time

On weekdays between 4:00 PM and 9:00 AM

- Therefore, open burning of leaves and small branches may only be legally conducted during weekdays from 9:00 AM to 4:00 PM at which time the fire shall be fully extinguished.

- Before any legal open burning is conducted, the Longwood Fire Company must be informed in advance and the fire comply with all fire department requirements. It should be noted that approval by Longwood Fire Co is necessary, but not sufficient. The Township regulations must be adhered to regardless of Longwood Fire Co approval.

There have been several instances of illegal open burning in the Township this past year and some have argued that the Longwood Fire Company said it was OK. Their OK is required, but it alone is not permission to burn. Also, Township notices regarding leaf and branch pickup carry the underlying ordinance restriction regarding open burning.

Please be good neighbors and comply with the Township open burning regulations.

## Planning Commission Update

Jeff Streitel joined the Planning Commission following his appointment by the Board of Supervisors at their January 4 meeting.

As previously reported, work continued on a Cooperative Planning Project involving Longwood Gardens, the Chester County Planning Commission and East Marlborough, Kennett and Pennsbury Townships. We expect to conclude the Pennsbury's role on this project in March and will forward it on to the Board for their review and consideration.

At our January organizational meeting, the following officers were elected for 2016: Chair - Dennis Smith, Vice Chair - Bob Crandell and Secretary - Lynn Luft.

Additionally, the following people were appointed to represent the Township on the listed organizations: Jim Ware - The Kennett Area Regional Planning Commission, Margo Leach - The Brandywine Battlefield Task Force and Lynn Luft - The Historical Commission.

The PC heard a Zoning Variance Application requesting a side-yard setback and voted to recommend that the Board support the application so long as the immediate neighbors have no objections.

Work on the following topics was concluded and forwarded to the Township Solicitor, Tom Oeste, and the Board for their review and consideration: Amendments to the Zoning Ordinance on Village Residential, Village Commercial, Accessory Structures and Riparian Buffers.

A joint Planning Commission and Board of Supervisors meeting was held to review progress on our 2015 Township goals and establish goals for 2016.

All Township residents are welcome at Planning Commission meetings which are scheduled for the second and fourth Tuesdays of each month at 5:00 PM in the Township Building.

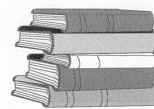

## A Pennsbury Historic Building — Pennsbury Inn

The Pennsbury Inn was once part of the John Hope farm (see 2016 Winter Newsletter). It is located at an important local crossroads on the Chester Road, now the Baltimore Pike, the center of Pennsbury village life in the 1800's. The Inn is on the north side of the Pike, hidden from view by a wooden fence at the highway intersection with Hickory Hill Road. First built as a private residence in the early 1700's, the Inn is one of the best Township examples of historic preservation and adaptive reuse of historic resources.

The Inn's initial construction date is unknown. Provincial tax accounts are vague, lacking specific building descriptions. The design and construction method of the Inn's early stone section are very similar to that of the John Hope House, leading to the supposition they both were built in the early eighteenth century, perhaps by the same craftsmen.

In John Hope's 1749 will, he left his youngest son Amos most of the family farm, and mentioned only one house, assumed to be the Hickory Hill Road structure.

By 1769, when Amos Hope made his own will and died, Court records show he resided in the stone and brick house, now known as the Pennsbury Inn.

Amos specifically instructed his wife in his will to sell the original John Hope House on Hickory Hill Road with 170 acres to Joshua Pierce. Amos asked his friend, Dr. Joseph Pierce, to survey the land and make a division map of the two properties, which has been preserved at the Chester County Historical Society.

Although the Hope family went through a very stressful time, Amos' estate was finally settled in 1772. Dr. Pierce married Ann Hope, Amos' widow, and his nephew, Joshua Pierce, bought the original John Hope House on Hickory Hill Road. The stone and brick house, along with 180 acres, continued to be the private home of Joseph Pierce's family for forty-five years.

The nineteenth century brought increased commerce to Chester County. By 1822, new owners of the Pierce

property, the Lancaster family, sought a tavern license to take advantage of the house's location on the main road between Philadelphia and Baltimore. This was the first adaptive change of use for the structure and the beginning of the Inn's history as a public meeting and lodging place that continued until 1900.

The Lancaster family's first tavern license application was denied with much objection from the Quaker community to the public sale of alcohol. Later tavern license applications by the Lancasters noted the use of the Inn as a community meeting and polling place, and as an important stop for travelers crossing the Brandywine or heading to Delaware.

A tavern license was eventually granted in 1826, and the Lancaster (or Pennsbury) Inn opened for business. However, when Joseph Lancaster was fined 10 shillings for 'tipling and drinking' on First Day in 1846, the tavern license was cancelled. In retaliation, the Lancasters halted use of the Inn as a polling place in 1847. Tempers gradually moderated and the tavern license was renewed in 1851.

Despite several other years with license cancellations, the Inn continued to operate as a popular lodging and meeting place until the late 1800's. After the property was sold at Sheriff's Auction in 1900, the Inn reverted to private use, changing hands several times in the early twentieth century.

The Haldeman family became the property owners in 1951. They initiated much needed renovations and built the house's last addition. As the Baltimore Pike was widened and modernized, the Haldemans sought to protect the pre Revolutionary structure by applying for National Register of Historic Places recognition. With National Register status achieved in 1971, highway construction affecting the Inn must follow a special review process.

The present owners of the Pennsbury Inn, Cheryl and Chip Grono, have adapted the house to a new life once again as a bed and breakfast. They reopened the Inn to public guests thirteen years ago, recognizing the growing tourist interest in the Brandywine Valley.

A stay at the Inn and tour of the garden offer a delightful respite from the 21st century, a glimpse into another era with the chance to learn about Pennsbury's place in local history. 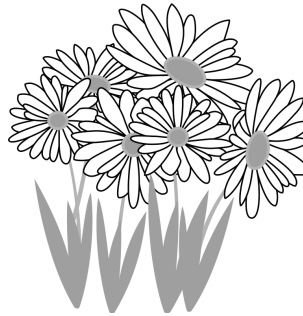
## **Electronics Recycling**
