


### TOWNSHIP LAND TO BE PRESERVED IN PERPETUITY

**O**n December 14 a Conservation Easement was placed on three parcels totaling approximately 23 acres surrounding the Township Building. In December 2014 the Township settled with Toll Brothers and purchased the land from them to avoid a very dense development of townhouses and carriage homes.

The Brandywine Conservancy worked with the Township as well as the Pennsbury Land Trust to put together an easement restricting further development on those lands in perpetuity.Restricting it from further development has been a goal of the Township and this has now been realized.

Next, the Township plans to put together an open space management plan for the maintenance of the land and will work on getting grant monies for this.

# Township equipment is ready and waiting for the winter ahead

### • DO NOT PARK ON THE STREET DURING

**STORMS.** If our drivers do not think they can salt, cinder or plow a street or cul-de-sac safely, they will SKIP it or plow it last. If vehicles are still on the street, the Township will have them towed at the owner's expense.

• SECURE YOUR MAILBOX. The Township is NOT responsible for damage caused by snow or ice that is thrown from the snowplow blade or passing vehicles. Standard mailboxes and posts are replaced by the Township ONLY if either or both are actually struck by the plow and if these are installed to the specification of the US Postal Service. The Township neither replaces or reimburses residents for custom mailboxes or ornate posts. If you believe a properly installed mailbox or post was struck by a Township vehicle, contact Road Master, Dave Allen at 610-388-9180


• **KEEP THE RIGHT-OF-WAY CLEAR.** Any installation of plants, mailboxes, etc, is done at the owner's risk.

• DO NOT PUSH SNOW INTO THE STREET. Wait until the roadway is cleared before shoveling your driveway. If you must clear these areas, know that Township trucks will likely throw snow back onto your property when plowing the road. This is unavoidable. Shoveling snow back into the road creates a safety hazard and could cause an accident.

•MAIN SUBDIVISIONS WILL BE PLOWED FIRST. Less populated areas next. The Township plows ONLY municipal roads — not state highways. PennDot plows Baltimore Pike, Route 52, Route 926, Pocopson Road and the part of Parkerville Road which is not Township..

#### 2017 TAX BILLS

Tax bills for 2017 will be will be arriving in January and February.

Chester County tax bills will be mailed in January and the Township tax bill will arrive in February.

Please be aware there is an Earned Income Tax of .312% in Pennsbury Township which is collected by Keystone Collections. It is your responsibility to make sure this tax is paid by April 18, 2017 if this tax has not been deducted. If you have questions, contact Keystone Collections at 888-328-0565

School tax bills are sent out by the school district July 1 of each year.

### \*FENCE PERMIT

A zoning permit is required to install a fence in the Township. Regulations for fencing can be found on-line under Zoning Ordinance Sec. 162-1915. Permits are on the website at <u>www.pennsbury.pa.us.</u>

Fence placement and height are important to know. Make sure you understand the definitions of *front yard* and *side yard* as the requirements are different.

Underground pet electric fences do not need a permit.

### BRANDYWINE BATTLEFIELD TASK FORCE AWARD COINCIDES WITH TOWNSHIP EASEMENT

**P**reservation Pennsylvania, the Commonwealth's only statewide private, nonprofit organization dedicated to historic resource protection, has awarded the Chester and Delaware County Planning Commissions' Brandywine Battlefield Task Force its 2016 Chairman's Award. The Task Force was selected due to six years of research and preservation planning with municipalities included in the areas of known troop movements during the 1777 Revolutionary War battle, one of the largest and most important engagements fought during the American colonies struggle for independence.

Beginning in 2010, funded by the American Battlefield Protection Program, the Task Force identified fifteen Townships located within the known battle area. Task Force goals included: verifying troop movements; identifying Revolutionary period resources still in existence; developing educational programs for schools, residents, and tourists; and assisting municipalities in preservation planning for Battlefield resource areas endangered by development.

Coincidentally, as a result of ongoing separate municipal efforts, Pennsbury Township will finalize property conservation easements for three land parcels fronting Route 1 in December. These particular Township property purchases, made with Township Open Space and Pennsbury Land Trust funds, along with the completed easements, will help preserve parts of the Brandywine Battlefield previously scheduled for high density housing.

The Township municipal building property and the three parcels were part of an 18th century Penn Land Grant. The Land Grant's two main historic private residences, which are not included in the easements, still rest on either side of the Baltimore Pike at the junction with Hickory Hill Road. These old stone houses, outbuildings, and surrounding woodlands sheltered Colonial soldiers who attempted to deter Hessian troops with gunfire as they marched from Kennett Square toward Chadds Ford on September 11th, 1777.

The easements will leave historic land for Pennsbury residents to enjoy as Open Space, thanks to Township initiatives. The Pennsbury Historical Commission extends its congratulations to everyone involved with both projects and is grateful to be part of such a community.

## UNIONVILLE-CHADDS FORD SCHOOL DISTRICT NEWS

The school district had a very busy fall. Here are a few highlights from the first few months of the school year.

We are progressing on one of our board goals which is to evaluate changing the school start time for our middle school and high school students. The School Start Time Committee composed of board members, administrators, faculty and parents, is actively researching options for the administration to consider. We were fortunate to learn more the topic and the underlying science when Dr. Judith Owen provided a presentation titled "The Science Behind Later School Start Times." Please visit the district web site to view the presentation and to keep abreast of the committee's efforts. We expect to have a decision in the March-April time frame.

In September the district was able to refinance about \$61 million in bonds and generated over \$8 million in current dollar savings. We were able to take advantage of extremely low rates in the municipal bond market and the savings will be reinvested into our long term capital needs.

In November, the six Principals provided their annual achievement report. Though there is always room for improvement, each school reported very high levels of academic achievement. Five of our 6 buildings are ranked in the top 10 in the state of Pennsylvania and the high school recorded the highest School Performance Profile score in the state.
